TERMS AND CONDITIONS

- A. **Payment:** An exhibitor or delegate, who has not paid their fees in full before the opening of the event shall not be permitted to participate until these fees are paid.
- B. **Stand location:** if the organizing committee has allocated a space to the exhibitor in advance of the exhibition and the exhibitor has not complied with the payment deadlines, then the organizing committee will have the full right to move the exhibitor to another location and give their previous location to another company.
- C. **Conduct:** exhibitors must not obstruct the view of other exhibiting companies, play loud music which will distract other participants or remove their stand prior to the official closing of the exhibition.
- D. **Insurance:** participants agree to ensure that at all times it shall have adequate insurance cover for any loss or damage incurred by an another participant or a third party in connection with the event.
- E. **Cancellation:** If any delegate or exhibitor wishes to cancel their application to attend the event, they must give notice in writing. If notice is given one month or less before the opening of the event, the organizers will retain all fees that the participant has transferred. If a participant cancels one month or more before the start of the event, then the participant will receive a refund of 20% of all fees tendered.
- F. **Force majeure:** the organizers will not be responsible or liable for loss, damage or delay resulting from acts of war, civil commotion, strikes or lockouts, default or failure of suppliers, government action, intervention, military activity, Act of God, fire, flood or any other circumstances beyond the organizers control which make it impossible or inadvisable for the event to be held at the time or place provided. If this occurs, the organizers have the right to reschedule the event at an alternate date and site. The participant acknowledges that the organizers have suffered loss as a result of this and hereby waives all claims for damages or compensation. The monies paid to the organizer in connection with the event will remain the property of the organizer.
- G. **Passport and visa:** the organizers will assist participants with their visa invitation process to attend the event. The organizers are not liable for any damages which are resultant from participants not obtaining their entry clearance due to: decisions made by the country authorities, delay in receiving applications and feedback from these authorities or inaccurate information that is supplied by participants. Should an participant fail to obtain their visa there are still liable for any monies owed as part of the event contract.
- H. **Exclusion and limitation of liability:** The participant acknowledges and agrees that the organizers will not be held liable for any loss or damage incurred by the participant as a result of fault negligence of the organizers with regards to: the actions or omissions of freight shipment contractors, the theft or loss of equipment or personal effects and any other activities that have been sub-contracted by the organizers.
